Vested shares will be delivered to the reporting person on these dates of each respective year.

- Shares withheld to satisfy tax withholding obligations upon vesting of restricted stock.
- On 07/01/2020 3,530 restricted stock units were granted. The restricted stock units vest on June 30, 2023.
- On 07/19/2019, 2,508 restricted stock units were granted. These restricted stock units vest on June 30, 2022.
